- (v) Regarding filling up of the examination forms for first year/second year/third year. G.N.M./ A.N.M., Please follow the guideline on pages 34 to 38 for G.N.M. & 18 to 22 for A.N.M. of I.N.C. syllabus and regulation, under heading. "Scheme of examination".
- (vi) The admit cards of eligible candidates will be ready by 07.11.2022. Please send a messenger with an authorization letter to collect the admit cards on or after the date mentioned above.
- (vii) Please submit Internal Assessment Marks as per I.N.C. syllabus in prescribed form provided by J.N.R.C. at the time of submission of examination application forms of G.N.M./ A.N.M, under sealed cover duly signed by Principal School of Nursing and counter signed by the Director / superintendent / C.S.
- (viii) Please submit the photocopy of verification report of academic education duly attested by principal at the time of receiving of examination application forms.
- (ix) Do not attest the extra photograph of the candidate attached with Examination form. It will be used for Registration of candidates.




