

INSTRUCTIONS TO CANDIDATES WHO WISH TO APPLY FOR SCRUTINY OF MARKS

1. Candidates for all examinations conducted by this Council are eligible to apply for scrutiny of marks, (There is no provision for scrutiny in respect of answer books in Practical examinations)
2. Every application should be submitted by the candidate **Through Proper Channel** in the prescribed fee mentioned under clause (3) below, so as to be received by the **Registrar Jharkhand Nurses Registration Council Ranchi, Jharkhand 834009** within **15 days from the date of publication of result or within 10 days from the date of receipt of mark list at the center of Examination, unless otherwise specified by the council.** Candidate are advised to send their application by **Registered post** addressed to. **Registrar Jharkhand Nurses Registration Council Ranchi, Jharkhand 834009** with the superscription on the envelope 'Application for revaluation ANM or GNM
3. The fee for scrutiny of marks is Rs. 200/- (Rupees Two Hundred only) per subject. Which is to be submitted online at www.jnrcranchi.com and a copy of receipt should be send along with the application form.
4. Application for scrutiny of marks should be accompanied with envelope mentioning address of Training Institute along with sufficient stamp for sending the result by registered post.
5. Applications which are incomplete, late and not in the prescribed form will not be entertained and will be summarily rejected without notice.
6. The result of revaluation will be communicated to the candidates through proper channel in the address of Training Institute furnished in their applications, as soon as the results are ready for issue. No interim enquiries of any kind will be entertained in this regard.
7. After Scrutiny of marks, marks obtained by candidate may increase/decrease.
8. The result of scrutiny of marks will be issued by the council by minimum 60 days from the time of receiving the application.
